Mr. Joe Furman, Planning and Inspections Director, presented proposed amendments to two County ordinances as recommended by the Planning Board. The first amendment was to the Ordinance To Govern Subdivisions and Multi Unit Structures. The Planning Board has requested to add Subsection 71.0233 which would provide a mechanism for developers that had preliminary plats approved with 18 foot wide roads and began construction prior to the new 20 foot requirement to receive plat approval, without requesting a variance, if they meet the requirements of the new Subsection. In May, 2012, the ordinance was amended to increase the required road width from 18 to 20 feet in order to be consistent with the NC Fire Code.

The second amendment was to the Sign Ordinance. New electronic billboards are prohibited under the ordinance, however on-premise electronic variable message signs for businesses, churches, etc. are allowed. The Planning Board has requested to change the time the message must remained fixed from one (1) hour to fifteen (15) seconds.

VENDOR AWARD REQUEST FOR HAZARDOUS MATERIALS TRAINING EXERCISE

At the November 19, 2013, Board meeting the Board approved the submission of a grant application to the North Carolina Emergency Management for a hazardous materials exercise in the amount of \$10,000. The grant required no County match and would be a pass through grant with Avery County. The exercise scenario would be an accident in which hazardous materials would be released into the Watauga River affecting the counties of Watauga, Avery, Johnson and Carter with the latter two being located in Tennessee.

Fire Marshal Steven Sudderth stated that a Request for Proposal was issued for a vendor to carry out the training exercise. The following proposals were received:

Mr. Sudderth recommended RLMC-Group be awarded as the vendor for the training exercise. After review with Avery County and Johnson County Emergency Management Departments it was determined that RLMC-Group would best provide the service of an HSEEP Compliant regional exercise.

Watauga County Economic Development Commission

County Manager Geouque stated that the Watauga County Economic Development Commission had one remaining term set to expire in June. The current member was not eligible for reappointment due to having served two consecutive terms. Commissioner Kennedy stated that Ms. Evelyn Asher was not available to serve as she was in the process of moving out of County. A volunteer application was also received from Mr. Walter Kaudelka who had expressed interest in serving; however, this was a first reading and, therefore, no action was required.

Region D Development Corporation

County Manager Geouque stated that Region D Development Corporation was a Certified Development Company that assists the US Small Business Administration in delivering small business loans to the region. They also assist in marketing and packaging loans for small businesses throughout the region. Per their bylaws, each county is required to appoint four persons to serve as members of the Development Corporation in May of each year. Representative categories are local government (1), private lending institution (1), and community organization or a business organization (2).

The County Manager stated that the following were appointed at the May 20, 2014, meeting: Mr. John Spear (local government); Mr. Brian Crutchfield (community organization); Mr. Jim Furman (business organization).

An appointment still needs to be made for the private lending institution representative.

County Manager Geouque stated that the Boone Town Council recommended appointment of Mr. Thomas Purpur as an ETJ member of the Town of Boone Planning Commission.

**SPECIAL AUTHORIZATION - COUNTY MANAGER AS

RESTRICTIONS - COUNTY MANAGER (BUDGET OFFICER)

- A. The interfund transfers of monies, except as noted in XXXII (paragraphs C and D), shall be accomplished by Board authorization only.
- B. Salary increases shall be granted in accordance with the official pay plan of Watauga County, duly adopted by the Board of Commissioners.
- C. Utilization of appropriations established in the following funds may be accomplished only with the express approval of the Board:
 - 1. Debt Service Fund
 - 2. Capital Projects Fund
- D. The County Manager shall be authorized to reallocate contingency funds from the General Administration budget. Such transfers or expenditures shall be reported to the Board at its next regular meeting, and recorded in the minutes per NC General Statute 150-13(b)(3).

SEC. XXXII

UTILIZATION OF BUDGET AND BUDGET ORDINANCE

This Ordinance and the Budget Document shall be the basis of the financial plan for the Watauga County Government during the 2014/15 fiscal year. The Budget Officer shall administer the budget, and he shall insure that operating officials are provided guidance and sufficient details to implement their appropriate portion of the budget. The accounting section shall establish records which are in accordance with the budget and this ordinance and the appropriate statutes of the State of North Carolina.

State derived reimbursement revenues are budgeted based on current State of North Carolina law. If these reimbursements are eliminated or otherwise altered, these alterations will be reflected by budget amendments at a later date.

BACKGROUND

Kanipe Construction was awarded the construction contract for the Rocky Knob Park Bathroom Project on February 18, 2014. Kanipe submitted a very competitive bid by underbidding the closest bidder by \$22,210. Construction began mid April and is slated for completion by August 31st. To date, the septic system has been completed, the building has been dried in and the subcontractors are installing plumbing and electrical systems.

On June 10, Kanipe Construction met with Watauga County Planning and Inspections to discuss the Icenene blown in insulation. The inspector recommended increasing the amount of insulation in order to prevent a possible moisture problem in the future. The recommended thickness is approximately double what is specified in the building plan. The cost for adding the additional insulation is \$350.

Also, on June 10, I discussed a problematic building detail the contractor has been trying to solve. The building plans do not sufficiently detail the last two timber frame rafters on each end of the building where the framing members are exposed to the weather. Additional trim will need to be added to provide weather tightness and cover the transition from block to framing. The cost to add the additional trim not in the original contract is \$300.

FISCAL IMPACT

I have spoken with Wright Tilley and Matt Vincent with the TDA and they both are in agreement that this Change Order Request is in order and they will approve \$650 to cover the cost of this Change Order.

STAFF RECOMMENDATION

Staff has reviewed the Change Order #2 for \$650 and recommends that it be approved.

The North Carolina Historic Preservation Office is requiring that we conduct an archaeological survey of the disturbed area at the Medic Base #3 site. Apparently, the Historic Office and the Army Corp of Engineers believe there is a possibility that the site may contain artifacts that need to be documented. I have corresponded with the Historic Office and the ACOE and thus far, been unsuccessful in dissuading them to not require this study.

Brushy Fork Environmental has agreed to work with Valor Engineering to complete this study. The cost will be \$1,950 and will be invoiced through Valor Engineering.

RECOMMENDATION

Staff recommends approval of this study in order to expedite the permitting process.

Services:

A Phase I Archaeological Survey of the Federally classified wetland area associated with the proposed Emergency Response Base project, located in Watauga County, North Carolina is proposed. In compliance with federal and state guidelines, the survey will minimally require: (1) a review of previous archaeological and historical research within the immediate area and of potential relevance to the project; (2) a visual inspection of the project area surface; and (3) excavation of 40 X 40 cm test pits (approximately ten) spaced at 10-20 m intervals along the southwestern margin of the wetland. These will be excavated by shovel to a depth of ten cm below subsoil (A-B horizon or plow zone) and the soil dry-screened through ¼-inch (6 mm) mesh. In addition, auger testing via a one-inch open faced soils sampling tool will be undertaken within the wetland area to evaluate the potential presence of archaeological evidence buried by alluvium.

Should cultural resources (e.g., artifacts) exceeding 50 years in age be identified by the survey, hand excavation of one or two 1 X 1 m units adjacent to each point of discovery (i.e., test pit) will be undertaken to increase the artifact sample and provide a better view of contextual and material conditions. Soil from these also will be dry-screened through ¼-inch mesh. Any artifacts or other indicators of past human activity recovered will be packaged and labeled for subsequent laboratory processing and analysis. A field map of archaeological explorations and potential discoveries will be drafted on site.

If auger testing identifies the potential existence of deeply buried cultural resources within the wetland, a deeper excavation unit (perhaps up to 1 m) may be required to evaluate their significance. If human remains or any other indication of the presence of human remains are identified by the survey, fieldwork will be immediately halted and the North Carolina Historic Preservation Officer consulted.

Reporting:

Two copies of the resulting archaeological survey report of the archaeological survey and recommendations will be provided in electronic and paper forms for submittal to the North Carolina Department of Cultural Resources SHPO office.

Schedule:

THIS AGREEMENT, made and entered into this the ____ day of _____, 2014, by and between the Beaver Dam Volunteer Fire Department of Watauga County, Inc., a non-profit fire department (hereinafter referred to as "Beaver Dam VFD") and Fall Creek Volunteer Fire Department of Avery County, Inc., a non-profit fire department, (hereinafter "Fall Creek VFD") is for the purpose of providing response by the Fall Creek VFD to certain areas within the fire district of Beaver Dam VFD, and Watauga County, a North Carolina political subdivision and body politic of the State of North Carolina (hereinafter "Watauga County").

Whereas, Beaver Dam VFD is a non-profit fire department established for the purposes of providing fire protection within its fire district for the citizens and property owners within the district; and

Whereas, Fall Creek VFD is a non-profit fire department established for the purposes of providing fire protection within its fire district for the citizens and property owners within the district; and

Whereas, certain areas within the Northwest Watauga Fire District of Watauga County are located within their response district but outside their rated district as defined by the North Carolina Department of Insurance; and

Whereas, Fall Creek VFD is geographically located such that it is in a position wherein it can provide rated coverage for certain areas within the Beaver Dam VFD response district, and is willing to do so subject to the terms and conditions set forth herein.

NOW, THEREFORE, Beaver Dam VFD, Fall Creek VFD, and Watauga County, in mutual consideration of the terms and conditions set forth herein, and upon the recitals set forth above, do hereby agree as follows:

1. Fall Creek VFD shall provide primary response coverage to calls for service within the response district area shown on the map attached hereto as Exhibit A and incorporated by reference. Fall Creek VFD agrees to furnish and provide continuing fire protection service to property within this service area by dispatching upon call of any resident or property owner within the service area described by this agreement, and shall provide adequate personnel to provide such service.

2. Watauga County shall make a quarterly payment to Fall Creek VFD for taxes actually collected from the specified territory as shown on the map attached hereto as Exhibit A for the provision of these services. Such payments shall be made quarterly to Fall Creek VFD. Beaver Dam VFD understands and agrees that pursuant to this agreement it shall not be entitled to receive fire taxes for the area subject to this agreement.

3. Fall Creek VFD shall at all times maintain an approved Fire District

rating through the North Carolina Department of Insurance for the area covered by this agreement, and shall take all steps necessary to remain an approved Fire Department with the appropriate State agencies.

4. This agreement may be terminated by either party without cause effective June 30 of a calendar year by giving written notice to the other and the Watauga County Board of Commissioners no sooner than the preceding January 1 of that calendar year to allow a period of 180 days to make alternate arrangements for fire protection for this area.

5. This Agreement is entered into in Watauga County, North Carolina, and shall be construed in accordance with the laws of the State of North Carolina. The parties hereby agree that Watauga County, North Carolina shall be the exclusive venue for issues arising as a result of this contract.

6. This Agreement shall not become effective until executed by all parties and approved by the Watauga County Board of Commissioners.



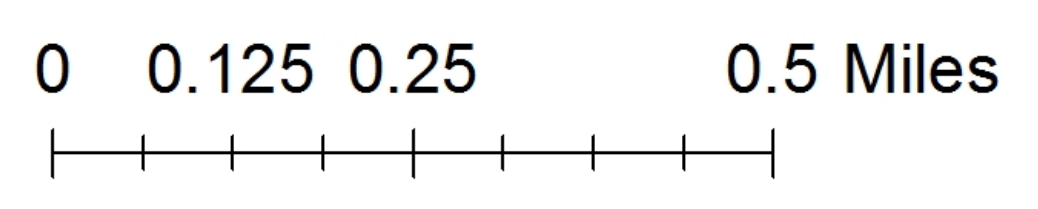
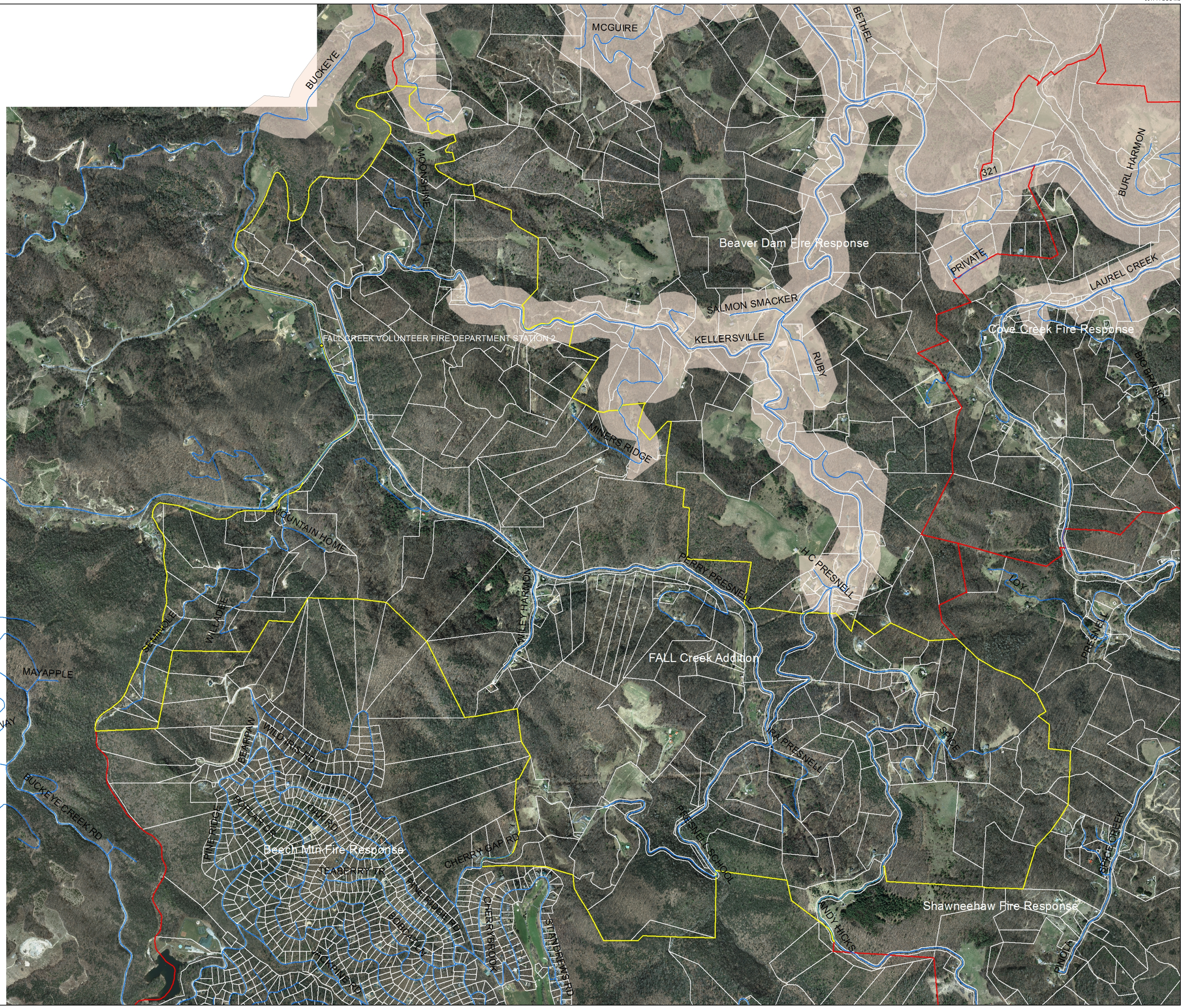

The Watauga County Sanitation Department, Recycling Office recently applied for funding from the “2014 Community Waste Reduction and Recycling Grant” offered by the NC Department of Environment and Natural Resources. DENR has offered a partial amount of the requested funds to help with this project.

The original proposal was a request for \$12,088 (DENR) with \$3,022 (in matching funds). NC DENR will fund \$4,000 of this to help purchase recycling containers for County Offices and Schools. Matching funds in the amount of \$848.68 will be split between Watauga County Schools and the Watauga County Recycling Office. The grant match is in the FY 2014-2015 budget.

Funds from this grant will be used to:

- purchase new recycling/waste containers for County Offices,
- purchase more recycling containers for Watauga County Schools

See attached revised grant proposal for more information and complete budget.

General Requirements

- **NC Solid Waste Disposal Tax Proceeds:** Watauga County verifies that all tax disposal proceeds are used only for the purpose of providing solid waste and recycling services. The amount Watauga County receives from the disposal funds is approximately \$23,000 per year. The cost of running the recycling center is \$100,000 – \$125,000 per year and these funds are used to supplement the recycling center budget.
- **Recycling at Government Offices:** Watauga County provides recycling bins in all county offices for paper, plastic bottles and cans. Recycling is collected weekly by Watauga County Maintenance Department. Cardboard pickup for county offices is provided as needed by Watauga County Recycling Office.

Project Description

County Offices: Grant funds would allow for the purchase of (350) 28-quart recycling bins with a small waste container attached to it. These containers would be placed at every county employee's desk where the employee would be responsible for taking recyclables and separating (plastic bottles, paper and aluminum cans) into larger roll carts that would be set up in six convenient locations in county office buildings. The recycling from these larger bins will be collected by Watauga County Maintenance weekly and delivered to the Watauga County Recycling Facility to be baled and sold to current markets. Currently, there are recycling bins in the halls for employees to recycle, but we expect to see a large increase in recycling, especially plastic bottles and aluminum cans, if everyone has a recycling bin at their desk.

All County Department Heads have approved and support this new system. Watauga County Recycling Office would help distribute these bins and provide education for employees through personal contact, e-mail announcements, newsletters, county memos and at departmental meetings. This process would be continued indefinitely with ongoing education for current and new employees.

The Watauga County Board of Commissioners has approved and supports this grant request as well as the Watauga Sanitation and Maintenance departments and the Watauga County School Board.

Schools: Please see project description below in the “School Recycling Special Requirements” section

School Recycling Special Requirements

- **Existing Program:** There are eight public elementary schools, one charter and one private school in Watauga County that have greatly benefitted from NC DENR grant funding in 2011 that helped supply recycling bins for all school classrooms, cafeterias, hallways, offices and libraries to collect paper, plastic bottles and aluminum cans and helped fund the production of “Jason’s Dream”, a recycling education puppet show, with the Ekland Art Center for all third grade classes. The recycling program in all of the schools continues to grow and one to two more of the 60-gallon indoor/outdoor recycling bins are needed at each school to expand the collection of plastic bottles and aluminum cans. Each school has also requested a few more of the 18-gallon bins for classroom paper recycling.
- **Collection from Schools:** Watauga County School Maintenance to picks up plastic, paper and aluminum cans from each school on a weekly basis. Watauga County Sanitation collects cardboard from all county schools on a weekly basis.
- **Recycling Market:** All recycling materials (paper, plastic bottles, aluminum cans, steel cans and cardboard) from schools are brought to the Watauga County Recycling Center where they are baled and sold to current markets.
- **Location of Containers:** There are currently recycling containers in each classroom and in offices for paper and containers in the cafeteria, hallways, break rooms and gymnasiums for plastic bottles and aluminum cans.
- **Collection in Schools:** Student groups at each school collect recycling (bottles, cans and paper) weekly from classrooms, hallways, break rooms and cafeterias and place in a central location for Watauga County School Maintenance to pick up. Cardboard is placed in bins behind the school by staff and is picked up by Watauga County Sanitation.

- Promotion and Education:** The Watauga County Recycling Office will continue to work with all schools to provide ongoing recycling education through classroom presentations for all grade levels, work with individual student groups, participate in the annual “Environmental Field Days” where every 5th grader in school system attends recycling and other environmental presentations, as well as promote and provide tours of the recycling center for field trips. The Recycling Office also attends school assemblies at the beginning of each school year to educate students and teachers about recycling opportunities at school and at home.

Project Timeline: The purchase and distribution of recycling bins and containers for schools and county offices would begin immediately following grant approval (July 2014). Education for county employees would begin with distribution of the recycling containers and would continue on a regular basis throughout the year.

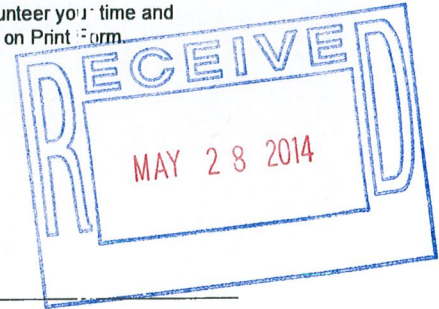

MANAGER'S COMMENTS:

A public hearing was scheduled to allow citizen comment regarding proposed amendments to two County ordinances as recommended by the Planning Board. The first amendment is to the Ordinance To Govern Subdivisions and Multi Unit Structures. The Planning Board is requesting to add Subsection 71.0233 which would provide a mechanism for developers that had preliminary plats approved with 18 foot wide roads and began construction prior to the new 20 foot requirement to receive plat approval, without requesting a variance, if they meet the requirements of the new Subsection. In May, 2012, the ordinance was amended to increase the required road width from 18 to 20 feet in order to be consistent with the NC Fire Code. The proposal is attached.

The second amendment is to the Sign Ordinance. New electronic billboards are prohibited under the ordinance, however on-premise electronic variable message signs for businesses, churches, etc. are allowed. The Planning Board is requesting to change the time the message must remained fixed from one (1) hour to fifteen (15) seconds. The proposal is also attached.

At the conclusion of the public hearing the Board may take action, if so desired.

 The Planning Board is proposing minor amendments to two County ordinances as follows.

Ordinance To Govern Subdivisions And Multi Unit Structures: In May, 2012, the ordinance was amended to increase the required road width from 18 to 20 feet in order to be consistent with the NC Fire Code. Recently, we have discovered several instances of subdivisions that received preliminary plat approval prior to the recession that had 18 foot wide roads constructed, but due to the economy never returned for final plat approval. The preliminary plats have long since expired, meaning the 20 foot requirement would be applicable when the developers seek preliminary plat renewal. It is impractical to require the additional two feet of roadway; relief can be provided through granting of a variance, which because of NC Statute changes is now a more complicated and expensive process than was previously needed for this ordinance. Accordingly, the Planning Board is proposing an amendment that will provide for the needed relief without going through the variance process. The proposal is attached.

Sign Ordinance: The sign ordinance does not allow new electronic billboards but does allow on-premise electronic variable message signs for businesses, churches, etc. Section C. 2. of the ordinance sets forth the regulations for such signs. Subsection b. provides that the sign's message must remain in a fixed position for 1 hour before changing. The Planning Board has been considering that provision and believes it is unreasonably long. Unfortunately, standards for such signs statewide and nationwide vary dramatically so there is no consistent standard to embrace. The national standard for highway billboards is that messages can change every 8 seconds; there is no national standard for these smaller on-premise variable message signs. In NC, standards for these types of signs range from allowing changes every 8 seconds to 8 times daily. After much consideration, the Planning Board is suggesting a 15 second change interval. That proposal is also attached.

Should the Commissioners desire to consider these proposals, a public hearing is necessary prior to adoption.

Proposed Amendment to Ordinance To Govern Subdivisions and Multi-Unit Structures

Add new subsection 71.0233 as follows.

71.0233 In the case of roads which were approved and for which construction began prior to the adoption of the 20-foot width requirement on May 15, 2012, the Planning Board may allow 18-foot road width provided the Board determines the following.

- a) the subject road received a preliminary plat approval prior to May 15, 2012, and
- b) the road was substantially completed to the formerly-required 18-foot width, and
- c) it is impractical from an engineering or environmental perspective to increase the width to 20 feet. Examples include, but are not limited to: 1) underground utilities have been placed in the road right-of-way, 2) cut and fill slopes have been stabilized and additional grading would unnecessarily affect the slopes, 3) the subject road segment is the final segment of an existing road.

C. Prohibited Signs.

1. Signs that are structurally unsafe and thereby endanger the public safety shall be removed unless they are repaired and made to comply with the requirements of the North Carolina State Building Code.
2. Flashing and moving signs are prohibited. A sign provided as a public service showing the time and temperature shall not be considered a flashing sign. Changeable electronic variable message signs are not considered flashing and moving provided the signs comply with the following provisions:
 - a. The sign does not contain or display flashing, intermittent, or moving lights, including animated or scrolling advertising;
 - b. The sign facing remains in a fixed position for at least ~~one (1) hour~~ **fifteen (15) seconds** (for on-premise signs);
 - c. If a message is changed electronically, it must be accomplished within an interval of two (2) seconds or less;
 - d. The sign must contain a default design that will freeze the sign in one position if a malfunction occurs;
 - e. A changeable electronic variable message sign shall be equipped with a control system that automatically adjusts light emission level to ambient light conditions so as to not cause glare or excessive brightness. In no case shall the light level of any such sign exceed 300 nits (candelas per square meter) between the time of sunset and sunrise, nor 5,000 nits at other times. No more than 25% of the sign message may be white. Notwithstanding the acceptable light levels, internal illumination shall not be at an intensity that is distracting to vehicular traffic; and
 - f. Subsequent to installation, Watauga County shall have the ongoing discretion to require that brightness, frequency, colors or other qualities be adjusted in order to address safety concerns.
3. Advertising and business signs that are tacked, nailed, posted, pasted, painted, glued, or otherwise attached to trees or rocks.
4. No source of illumination on a sign, such as floodlights, spotlights, unshielded bulbs, etc. shall shine directly into any public right-of-way. Internal illumination shall not be at an intensity that is distracting to vehicular traffic.
