Each team will be scheduled for up to 10 games. In regular season, games will be played to 15 points, must win by 2 points. Teams will be scheduled for 2-3 games each day. During tournament, matches will be scheduled with the best of 3 games to 11 points played, must win by 2.

PROGRAM INFORMATION

Players may choose to enter double, mixed doubles, or both.

Matches will be scheduled on Thursday evenings between 6pm & 9pm; The registration fee is \$50 per team per league.

The season will run from April 11 to May 16. Each team will be scheduled for 2-3 games every Thursday during the 6 week season. The 6-week season will include non-conference, regular season and/or tournament matches.

In regular season, games will be played to 15 points, must win by 2. In tournament, matches will be scheduled and the best 2 of 3 games to 11 points (must win by 2) will be played.

Teams should expect 2 or 3 games per day.

Tentative start date is Thursday, April 11. The program will run approximately 6 weeks.

Watauga County Parks and Recreation will provide nets and pickleballs. A limited number of pickleball paddles will be available to borrow.

All games and matches will be self officiated with a court monitor assisting with rule application.

Substitute players will be allowed. Substitutes may not be a team member on another team in the same division (i.e. A Thursday Doubles team may NOT borrow from another Thursday Doubles team, but may borrow from a Thursday Mixed Doubles team, or anyone not associated with any league team).

USA Pickleball Association rules will be followed unless otherwise stated in WCP&R's Pickleball Local Policies.

Participants must be 16 years of age or older to be eligible to participate.

In case of snow or other inclement weather in April, a decision on games will be made no less than 1-hour before the scheduled start of the first game of the day and will be announced on an automated phone message at 828-264-9512.
